

The CBGMA board met Saturday, March 9, 2019, at Bethel Assembly of God's fellowship hall in Corpus Christi. Present were Don Woods, John Holman, Len Hutsell, Larry Surginer, Jason Woods, and Emma Williams.

Len Hutsell opened in prayer.

Minutes of the board meeting held January 26, 2019, and the general membership meeting held February 16, 2019, were approved as reviewed following a motion by John Holman and second by Jason Woods.

The treasurer's report was approved as reviewed following a motion by John Holman and second by Len Hutsell.

Len Hutsell reported the Butter Churn schedule for the next few months:

Recording or filming of CBGMA functions is not to be allowed, following a motion by Larry Surginer and second by Jason Woods.

Butter Churn singings need at least two people (2 soloists, a group and soloist, or 2 groups) to sing, following a motion by John Holman and second by Emma Williams.

Legal representation will be decided by Don Woods, Larry Surginer, and Len Hutsell (president, vice-president, and chairman of the board) following a motion by Emma Williams and second by Jason Woods.

The next convention will be held February 21 and 22, 2020, due to the 14th being Valentine's Day, following a motion by Jason Woods and second by John Holman.

Next year's convention (2020) will be held at Glory Bound Baptist Church at Elmendorf, following a motion by Jason Woods and second by Len Hutsell.

Following a motion by Len Hutsell and second by John Holman, two showcases will be held to present possible songs for the song of the year award, one to be held in the Corpus Christi

area and one in the San Antonio area. Songwriters may present a maximum of three songs for consideration, the same three at each showcase, and may appoint someone to sing for them, should they be unable to do so.

Charles A. Shipp and Lydia Hutton became life-time members of CBGMA following a motion by John Holman and second by Emma Williams.

Dues for supporting members were changed from \$40 to \$20 per year following a motion by John Holman and second by Jason Woods.

Purchase of 500 stylus pens at \$0.69 each (\$345 total) to advertise CBGMA was approved following a motion by Len Hutsell and second by John Holman.

The next board meeting is tentatively scheduled for June 8, 2019.

A songwriter's showcase is tentatively scheduled in the San Antonio area July 27, 2019, from 1 to 5 PM at a location yet to be determined.
